# Terms & Conditions

## 1. Definitions

- 1.1. "Application" means a duly completed Membership Application Form of the Jersey Aero Club.
- 1.2. "Committee" means the Executive Committee of the Jersey Aero Club.
- 1.3. "Committee Member" means any duly elected member of the Committee.
- 1.4. "Club" means the Jersey Aero Club or any of its associated companies from time to time in being, their successors or assigns.
- 1.5. "Invitee" means any person accompanying any Member whilst at the Club or taking part in any activity involving any aircraft owned or operated by the Club.
- 1.6. "Member" means any Life, Full, Honorary, Visiting or Temporary member of the Club.
- 1.7. "Proposer" means any Life or Full Member of the Club of two or more years standing.
- 1.8. "Rules" means the House and Flying Rules for the time being in force and available at the Club.
- 1.9. "Seconder" means any Life or Full Member of the Club of two or more years standing.
- 1.10. "Secretary" means the Honorary Secretary for the time being of the Club.

## 2. Membership Application

- 2.1. Applicants must be proposed and seconded by a Proposer and a Secunder.
- 2.2. Applicants must be introduced to a Committee Member prior to submitting their Application to the Secretary.
- 2.3. All Applications must be accompanied by the appropriate subscription, cheques being drawn in favour of the JERSEY AERO CLUB.
- 2.4. Successful applicants will be notified by post and by notice in the Club.
- 2.5. Applicants not having reached the age of 18 must submit a duly completed GUARDIAN APPLICATION with their Application.
- 2.6. Applicants for Joint Membership must each complete an Application, submitting the same together to the Secretary.

## 3. Rules and Regulations

- 3.1. Members of the Club agree to be bound by the Rules of the Club and the terms and conditions herein set out.

## 4. Exclusion of Liability

- 4.1. The Club, its servants or agents, shall neither be responsible for or liable to any Member or their Invitees for any loss or damage, including personal injury or death, howsoever caused, whilst upon the Club or any premises or resulting from carriage or activity in or about any aircraft belonging to or operated by the Club.
- 4.2. Members agree that neither they, nor their heirs, dependants, executors, administrators or guardians shall make any claim against the Club for any loss or damage suffered by the Member whilst a member of the Club.
- 4.3. That in the event that the limiting paragraphs above are of nil effect loss shall be limited in the case of any one Member to the amount of the last membership fee applicable to that Member.

## 5. Indemnity

- 5.1. Members agree to indemnify the Club for any action brought by any third party against the Club or its servants or agents resulting from any act or omission of the Member.
- 5.2. Members agree to indemnify the Club for any action brought by any heirs, dependants, executors, administrators or guardians against the Club or its servants or agents as a result of any loss or damage, including personal injury or death, suffered by the Member, their heirs, dependants or other persons resulting from the Members or Invitees carriage, activity, access or egress on or to or from any aircraft owned or operated by the Club.
